In the course of preparing a work such as this, which undertakes to present a complete survey of a class of objects distributed among museums and collections in many countries, one must call upon the cooperation and generosity of numerous persons in several fields, and it is with pleasure and gratitude that I present here the names of those to whom I am accordingly indebted.
